

**NEW ELIGIBILITY REQUIREMENTS FOR PARTICIPATION
PROGRAM MALAYSIA MY SECOND HOME (MM2H)
UNDER
MINISTRY OF TOURISM, ARTS AND CULTURE**

GENERAL CONDITIONS

- (i) Applications to participate in the MM2H Program are open to individual foreigners from countries that have diplomatic relations with Malaysia;
- (ii) Aged 25 years and above for all categories.
- (iii) Application must be made through the operating company MM2H tourism licensed with the Ministry Tourism, Arts and Culture under the Industries Act Tourism 1992 [Act 482]. Any application by individuals or *walk-ins* will not be served; and
- (iv) All applications as MM2H participants whether the new or renewed (*renewal*) must be made through the MM2H One Stop Center. While all matters are related immigration and approval are regulated Ministry of Home Affairs and Immigration Department of Malaysia including appeals for rejected applications shall to YB Minister of Home Affairs.

A. Platinum Category

MEDICINE	Allowed to undergo long-term treatment long in Malaysia.
ACTIVITY BUSINESS/ INVESTMENT	Allowed.
OPPORTUNITY WORK	Allowed.
SCREENING HEALTH	Required to undergo an examination health at the clinic/hospital (panel clinic) which appointed by the Ministry of Tourism, Art and Culture for principals and dependents after getting approval to participate in the Program MM2H. This panel clinic is for confirmation services and charges applicable to all MM2H Program applicants are standard.
ADVANTAGE PROGRAM	Tax exemption on carried funds enter like FD.

Maximum withdrawal of 50% allowed on the principal value of the FD after getting approval to join MM2H program, for purchase purposes home, education, health and activities tourism in Malaysia.</p>
<p>PARTICIPATION FEE (ONE-OFF)</p>	<p>i. Participation fee of RM3,000 for prinsipal (one-off).</p> <p>i. NO entry fee for dependents.</p>
<p>PURCHASE HOUSE RESIDENCE</p>	<p>i. Required to purchase and own house after getting approval participate in the MM2H Program.</p>

Maximum withdrawal of 50% allowed on the principal value of the FD after getting approval to join MM2H program, for purchase purposes home, education, health and tourism activities in Malaysia.</p>
<p>PARTICIPATION FEE (ONE-OFF)</p>	<p>i. Participation fee of RM1,000 for prinsipal (one-off).</p> <p>i. NO entry fee for dependents.</p>

<p>PURCHASE HOUSE RESIDENCE</p>	<p>i. Required to purchase and own house after getting approval participate in the MM2H Program.</p> <p>i. Limit the value of the house that can be purchased by participants at least RM600 thousand or up.</p> <p>iii. Not allowed to resell home for 10 years. However allowed to upgrade the house (buying a new house) to the value of the house which is higher than the house which owned.</p> <p>iv. If the participant does not comply with the conditions- this condition, then the participant's MM2H pass can cancelled.</p>
